Includes all procedures, cost, and time required for a business to build a warehouse (simple structure)

Also assesses quality control and safety mechanismsin the construction permitting system

## HOW WE'VE MADE IT EASIER

#### Quezon City Construction Permits One-Stop Shop



Shorter transaction: From 23 steps to 8 From 122 days to 36

► Single, integrated application and approval for building permit, locational clearance, fire safety evaluation clearance, certificate of occupancy, fire safety inspection certificate, tax declaration (new warehouse), certificate of final electrical inspection, certificate of machinery operation

► Barangay clearance submitted after issuance of building permit

► Joint inspection by the office of the building official, city assessor's office and Bureau of Fire Protection

#### Joint Memorandum Circular on Construction Permits



► Sets uniform standards for processing building permits and certificates of occupancy, including application form, requirements, steps, processing time, one-time assessment and payment of fees

► Requires co-location of city offices and agencies in a one-stop shop and automation of processes for construction permits

### **REFORM MILESTONES**

- Shortened transaction time from 23 steps to 8, 122 days to 36
- Issued policy directives and implementation guidelines that establish stringent processing standards for construction permits
- Set up a one-stop shop with extensive backroom operations
- Strengthened institutional coordination among national and local government agencies and the private sector
