Quezon City Registry of Deeds Streamlined Procedures

Shorter transaction: From 14 days to 7

- ► Only 1-2 days to get a certified true copy of land title in electronic format (for simple transactions)
- ► Only 5 days to register properties with new owners (for simple transactions)



Land Registration Authority e-Services Automated records management and retrieval

- ▶ Registry of Deeds electronic database where clients can get information about a title's encumbrances
- ► Geo-spatial query services that helps clients locate a property using the approximate location or nearby points of interest as search criteria
- ▶ Parcel verification service for print-outs of parcel or lot configuration for clients who have the property title number
- ► LRA online tracking system to help clients check the status of their requests and transactions online
- ► Anywhere to Anywhere (A2A) system to request for a certified true copy of a title from any Registry of Deeds office, including extension office, that's connected to the network
- ► LRA Aksyon Agad Center for follow-up, inquiry, feedback and complaints

REFORM MILESTONES

- Shortened transaction from 35 days to 20
- Computerized transactions, records management and retrieval
- Multiple locations to receive requests anywhere in the country
- Electronic printing of documents


