

SME Roving Academy

The SME Roving Academy is an on-site management training program/learning institute for the development of micro, small and medium enterprises (MSMEs) to become competitive in the domestic and international markets.

Launched in 2013, the program is a partnership with MSME Development Council to provide MSMEs with "workshop-like training sessions" in the development of their operations.

It offers business modules tailor-fitted to the requirements of local entrepreneurs.

New entrepreneurs will be taught procedures on starting and operating a business. Once they are deemed ready to launch their products, they are qualified to join higher learning stages.

The Department of Trade and Industry implements the program in cooperation with other business development services providers; local government units: training institutions: academe: financial institutions: trade and industry associations; and other government and nongovernment organizations.



JANUARY 2016

Initially, no change was noted in prices of products including cooking oil, rice, pork and chicken in monitored establishments. Buffer supply is expected to last from three (3) days for fresh produce to two (2) weeks or one month for products with longer shelf life in Calapan City.



Supply of flour is enough to cover the requirements of the first district. Requests already received from the second district is being addressed by two (2) truckloads coming in by Thursday, December 17, 2015 (when public storm signal is expected to be lifted and port operations in Batangas and Calapan resume) to cover the need of the whole province.

In Pinamalayan, most business owners estimated supply to last from one week, while some, two weeks. Supermarkets in the locality have devised a way to control the number of people coming in to shop. 'Paktora' system and 30 people at a time were used due to only few of their personnel were able to come to work as most were also affected by the typhoon.

In Naujan, most said one week with only a few claim their stock could last up to two weeks.

At the time of monitoring, some establishments already need to replenish their stock of noodles and sardines. The same is true for construction materials such as umbrella nails, common 🔐 wire nail no. 3 and G.I. sheets need to be replenished already especially in Pinamalayan.

Enough supply depends on the expected deliveries from Calapan City and Batangas. Ro-ro trips have resumed after typhoon signals were lifted and roads leading to concerned municipalities were already cleared.

Damages to business noted were flooding inside some establishments affecting their products in Calapan City. In Pinamalayan, flooding inside some establishments affected their products, one establishment's ceiling collapsed due to water sippage.

In Naujan, damaged roof of some business affected their products. However, this was resolved through bayanihan o the 150 stall-owners in the municipality.


Our participation gives everyone a preview of DTI Oriental Mindoro's upcoming programs, projects and activities for this year 2016.

Effects/Impact of Typhoon Nona



Based on Office of Civil Defense IV-B Special Weather Bulletin No. 13, Typhoon "Nona" (Melor) made a landfall over Pinamalayan, Oriental Mindoro at 10 A.M. of December 15, 2015. It brought very strong winds, storm surge, landslides and flashfloods in affected areas of the province. As a result, it caused enormous damage to properties, livelihood and lives lost.

Per PDRRMC initial report, 12,310 houses were totally destroyed while 8,423 were partially damaged leaving 24,410 families or 108,740

individuals were internally displaced, 82 individuals injured and one missing and three dead.

About 9,395.37 hectares of agricultural lands were affected with an estimated cost of PHP202,241,550.00 in damages. On the same day, the Province of Oriental Mindoro was declared under state of calamity through Sangguniang Panlalawigan Resolution No.2853-2015.

Price Freeze of Basic Necessities

On December 18. 2015, President Benigno S. Aquino III signed Proclamation No. 1186, s. 2015 Declaring a State of National Calamity due to widespread destruction, substantial damage and deaths in several areas, including the Provinces of Albay, Sorsogon, Romblon, Oriental Mindoro and Northern Samar.



Monitoring of Price & Supply of Basic and **Prime** Commodities

The DTI-Consumer Protection and Advocacy Bureau requested concerned DTI Provincial Offices to intensify price and supply monitoring of basic necessities and issue notice of violations for those retailers selling above the price freeze on December 21, 2015.



DTI-Oriental Mindoro conducted supply and price monitoring of basic and prime commodities the day after Typhoon Nona struck, December 16, 2015, in Calapan City, in Pinamalayan December 17, 2015 and Naujan on December 23, 2015.

During the 3rd Annual Regional Competitiveness Summit/Cities and Municipalities Index (CMCI) 2015, 4 municipalities of Oriental Mindoro rose ranks together with Calapan City and the Provincial Government of Oriental Mindoro.

Out of 68 provinces, Oriental Mindoro placed 15th while Calapan City – a component city placed
