DTI-3 HOLDS SHARED SERVICE FACILITIES SUMMIT 2023

Micro, small and medium enterprises (MSMEs) play a major role in closing socio-economic divide and income inequality. According to the SME Finance Forum, they play a crucial role for growth and job creation, as MSMEs account for nearly 86% of employment opportunities in developing countries.

The program also aims at improving the quality and productivity of MSMEs by addressing the gaps and bottlenecks in the value chain of priority industry clusters through the provision of processing equipment for the common use of MSMEs within the priority industry clusters in every region.

At present, a total of 310 SSF projects have been established in Central Luzon since its commencement in 2013. A total of Php185,599,629.54 was disbursed and utilized in establishing these facilities across the region. With the use of modern machinery and equipment granted under the SSF Program, the MSMEs have improved their production capacities, enhanced the quality of their products and increased their market shares. As a result, 133,910 MSMEs were assisted/benefitted to date since the program's inception.

Thus, on January 18, 2023, at the Orchid Gardens, City of San Fernando, Pampanga the annual regional summit was held to gather all SSF stakeholders in one venue to celebrate the successful implementation of the SSF Program in Region 3 for the past year. The yearly event provides an avenue for SSF cooperators to share their success stories and best practices to serve as inspiration to other cooperators.



TARLAC JOINS 2023 AMBIENTE INTERNATIONAL TRADE FAIR IN GERMANY

A total of 10 Micro, Small, & Medium Entrepreneurs (MSMEs) from Tarlac showcased their handcrafted products at the Ambiente Trade Show in Frankfurt, Germany, from February 3-7, 2023, with the theme "Moving the Future".

Ambiente, one of the world's leading international trade shows for the consumer goods sector, made an astounding comeback in 2023 after being canceled for two years due to the Covid-19 pandemic. The staggering array of goods in the event was divided into four categories: dining, living, giving, and the newly added working section. More than 4,500 exhibitors from around the world came together to show off their latest kitchen and household goods, gifts, home decor, and furniture that took sustainability, design, and lifestyles into account.

The Provincial Government of Tarlac (PGT), the Department of Trade & Industry - 3 (DTI-3) through DTI Tarlac Provincial Office, and the Center for International Trade and Mission (CITEM) collaborated to enable 10 MSMEs from the province of Tarlac to partake in the Ambiente 2023 Trade Show. This time, there were more Tarlac MSMEs present as compared to Ambiente 2020, where a total of eight Tarlac MSMEs joined.

Over the course of the five-day event, the participating exhibitors interacted with 152 buyers and booked a total of \$28,954 in sales, while sales under negotiation totaled \$488,193.

"Tarlac's participation in the Ambiente Trade Exhibition demonstrates the readiness and competitiveness of its products. With adequate planning, strategies, and actions, MSMEs have the potential to adapt to the highly competitive markets of Europe and the rest of the world." DTI Assistant Secretary (DTI ASec) Leonila T. Baluyut, former DTI-3 Regional Director, said.

The MSMEs that took part were Red Slab Pottery, Betis Crafts Inc., PumiceUnlimited Ventures, Northshine Lightings and Decors Manufacturing, Oricon Corporation, Louriza Furniture Center, JCS Beatus Trading, Inc., Car-Ofel Woodworks and General Merchandise, Pascasio Pottery & General Merchandise, and Gracia's Amor Rattan Products Manufacturing. The latter five joined the trade show for the first time. Bath accessories, house decor, furniture, pottery, and lanterns are among the products exhibited by the participants. The PGT sponsored the MSMEs' booth rental, product shipping fees, and travel and lodging costs.

DTI Tarlac, CITEM, and the PGT, through the leadership of Governor Susan A. Yap, have been consistently working together in providing assistance to the MSMEs in Tarlac to expand their market by enhancing their skills, developing their products, and taking part in international trade fairs. The exposure of Tarlac products to the international market started in 2017 at the International Furniture Fair in Tokyo, Japan.



In addition, the team explored the potential market in China by taking part in the 2018 and 2019 China-ASEAN Expos in Nanning, China. Tarlac also took part in the Ambiente Trade Show in 2020 and was named the first CITEM artisan community partner.

"Ambiente's return in 2023 is definitely a success.

Though five out of the 10 exhibitors were first-timers, with the help of seasoned exhibitors, they were still able to effectively market their products. The friendship, teamwork, and positive attitudes of the MSMEs, along with the oversight and coaching provided by the DTI and the PGT-Provincial Cooperative and Enterprise Development Office (PGT-PCEDO), contributed to the overall success of the MSMEs' participation in the trade show." DTI - Tarlac Officer-In-Charge Provincial Director (OIC-PD) Zaida F. Garibay said.

Going forward, the collaborative team will continue to strengthen the 10 participants and develop more MSMEs by organizing higher levels of training programs for existing exporters and basic export training and mentoring sessions for potential exporters. With the effective convergence of government organizations and private MSMEs, Tarlac will eventually be able to establish itself in the global market.

PBBM LAUNCHES KADIWA IN BATAAN

Limay, Bataan - President Ferdinand R. Marcos, Jr. led the launching of the “Kadiwa ng Pangulo” and the distribution of government assistance on March 31, 2023 in Limay, Bataan.

Kadiwa's goal is to deliver agricultural products and other basic commodities directly to consumers in order to further increase the income of farmers and provide cheaper products compared to the market price.

“Ang konseptong ito, ang ginagawa natin ay pinag-uugnay natin ang magsasaka mismo hanggang sa palengke at ito na iyong palengkeng Kadiwa. Seventy-six (76) small businesses joined the caravan. Twenty-eight (28) of them were assisted by DTI. Some of the products featured in the caravan are bags, fresh mangoes, tuyo or dried fish, buko pie, cashew nuts, coffee, araro cookies, honey, turmeric tea, spicy dilis, squid and other processed food.

After the launch, PBBM also led the distribution of various government assistance to qualified beneficiaries. Key officials from DSWD, DOLE, TESDA, and DTI awarded livelihood packages to the recipients.

DTI Secretary Pascual led the sharing of financial assistance for small businesses mostly in food processing under the Resilient, Innovative, and Sustainable Enterprises Unleash your Powers (RISE-UP) Multipurpose Loan Program of the Small Business Corporation (SBCorp), the financing arm of DTI. Secretary Pascual distributed loan checks amounting to PHP10.9 million to forty-four (44) beneficiaries. RISE UP Program is a loan program that aims to sustain the gains of MSMEs that have survived the past two years of crisis, by providing multi-purpose loans that have soft terms and can be easily accessed.

DTI - 3 RET monitors Mandatory Products

The DTI3 Regional Enforcement Team (RET) conducted a regionwide monitoring and enforcement on mandatory products in the month of March 2023.

A total of fifty-five (55) establishments and hardware stores have been monitored among ten (10) municipalities and five (5) cities of Central Luzon.

During the monitoring, the RET issued one (1) notice of violation to an establishment for manufacturing and selling of fire extinguishers without the required Philippine Standard (PS) in violation of the Standardization Law. Consequently, the RET sealed and confiscated the uncertified products during the enforcement activity, and eventually destructed the same after the establishment has been administratively charged and finally penalized.



On the other hand, RET also reported that other establishments monitored are found to be compliant as to PS and ICC marking requirements.

Reports also showed that five hundred seventy-seven (577) products were covered during the monitoring which includes deformed steel bars, angle bars, cement, steel and plastic pipes, lighting and electrical products, household appliances, break fluid, ceramic tiles, and sanitary wares.



DTI R3 OIC RD Brigida T. Pili and OIC ARD Edna D. Dizon, graced the occasion and in their messages, they stressed the importance of understanding rights and responsibilities of consumers.

The webinar focused on the discourse of Handling Consumer Complaints in Business Establishments, lectures on Consumer Empowerment in Clean Energy Transitions and Philippine Renewable Energy. It was attended by 53 participants across the province.

In addition, DTI-Bulacan presented the organization and operationalization of the Bulacan Bagwis Circle. This aims to boost the cooperation and commitment of DTI certified establishments in the implementation of Bagwis program by policing member establishments to build harmonious relationship and linkages among the members. Said move provides strategy to promote Public-Private-Partnership towards consumer welfare and protection.

DTI CONDUCTS FORUM WITH MSMES IN THE BAMBOO INDUSTRY

The Department of Trade and Industry (DTI), in partnership with Nueva Ecija Small and Medium Enterprise Development Council (NESMEDC) and Nueva Ecija Bamboo Industry Development Council (NEBIDC), held a forum with MSMEs in the bamboo industry on January 20, 2023, at NEUST Campus in Gabaldon.

The Micro Small and Medium Enterprise Development Council, (MSMEDC), and the Bamboo Industry Development Council (BIDC) met in Nueva Ecija to discuss upcoming projects and programs that they could work on together for the benefit of the industry. The meeting also aims to expand the cooperation between private businesses and government agencies for the growth of numerous industries in the province, including weaving.

DTI Provincial Director Richard Simangan claims that the aforementioned industry is poised for many more developments, one of which is the desire to raise public awareness for its local production.

DTI continuously work with cooperatives especially those that could assist in the development of the bamboo and weaving industry in terms production, training, and market research. Some of the successful partnerships with DTI are the group of women in General Tinio, the Papaya Kababaihan Sinag Tala or PAKASITA who are providing skills to those who are just starting out in business. There is also Bambuhay from Carranglan which actively supports the propagation of bamboo and is providing nursery for those who are interested to forge partnership with them. In terms of the skills in weaving, some of the experts in Nueva Ecija in this particular industry are found in the towns of Bongabon, Carranglan, Gabaldon, General Tinio, and Llanera.

The NESMEDC, NEBIDC and DTI hope to further strengthen the bamboo and weaving industries in the province by attracting additional bamboo producers or cooperators that could assist weavers by identifying possible markets.



BULACAN TO HOUSE LARGEST GREENHOUSE FACILITY IN THE COUNTRY

Metro Pacific Agro Ventures, the agribusiness subsidiary of Metro Pacific Investments Corp. (MPIC) in partnership with Israel-based LR Group will be investing in a vegetable greenhouse complex on a 22-hectare lot in San Rafael, Bulacan. According to Metro Pacific Fresh Farms (MPFF), its greenhouse operation will be the biggest in the nation.

The facility would be able to offer 1,600 metric tons of vegetables a year, Metro Pacific Agro Ventures President and Chief Executive Officer Jovy I. Hernandez stated during the groundbreaking ceremony last February 20, 2023. The 7 hectares of the site will be used for two greenhouses, with the other 15 hectares being used for the irrigation centers, logistics warehouse, packing facility, and energy facilities.

A one-hectare greenhouse will be utilized for nutrient film technique hydroponics, and the other 6 hectares will be used for the drip irrigation system. These cutting-edge facilities will provide year-round production. Outputs are expected every 27 days while using 90% less water, 90% less land, and 90-99% less fertilizer and pesticides. With an expected investment of P800 to P1 billion, it will cover the full vegetable value chain, including the production of vegetable seedlings, vegetable growing, sorting, packaging, and marketing.

MPFF will supply farm-to-fork produce to Metro Manila and the surrounding provinces. Even with this infrastructure, just a small portion of the Metro Manila vegetable market can be served, according to Mr. Hernandez.

The initiative, according to Manny V. Pangilinan, chairman, president, and chief executive officer of MPIC, promotes the government's goal of food security. An independent Philippines in terms of agriculture is the goal of these investments, he claimed. "We want to help build a nation that's capable of feeding all of its people."

BJMP Arayat, DTI - Pampanga provide Business and Livelihood Training to PDLs

The Bureau of Jail Management and Penology (BJMP) Arayat in Pampanga has partnered with the Department of Trade and Industry (DTI) to provide business and livelihood training to Persons Deprived of Liberty (PDL). The initiative aims to help prepare the PDLs for their eventual reintegration into society by providing them with the necessary skills and knowledge to start their own businesses and become self-sufficient.

Jail Officer 1 Manolet Caranto, welfare and development officer of BJMP Arayat, approached the business counselor of Negosyo Center (NC) Arayat, Grace Afan, to discuss the possible partnership between BJMP and DTI. It was agreed that NC Arayat will conduct business opportunity seminars and other relevant seminars for the PDLs who are set to be released soon. The seminars will help the PDLs gain confidence and equip themselves with the necessary skills to start their own businesses and become financially independent.

The first run of the seminar was held last February 7, 2023, at the BJMP Arayat compound. Business Counselor Grace conducted a business opportunity seminar for 17 PDLs and other jail officers and OJTs.

Negosyo Center Arayat and BJMP Arayat also plan to partner with the Technical Education and Skills Development Authority (TESDA) to provide skills training for the PDLs. The partnership aims to make the initiative more holistic. Financial literacy will also be incorporated in the seminar line-up.

The BJMP Arayat believes that these intervention programs are necessary to help the PDLs in their personality development through skills and livelihood training, education enhancement, and spiritual nourishment. The programs are also designed to promote the welfare of marginalized people in the society.

Moving forward, the BJMP Arayat, DTI, and TESDA will continue to work together to ensure the preparedness of the PDLs for their reintegration into the society. The partnership is a testament to the government's commitment to provide support and assistance to those who need it most.

DTI-3 has assisted tinapa producers in this town through the Shared Service Facilities (SSF) program.

“Our barangay is known for our Tinapa and it is through this business that many families here were able to sustain their daily needs, particularly during the pandemic. The SSF given to us by the DTI gave us the inspiration to continue improving our product and innovate,” SSF beneficiary Mary Ann Sagum said.

In addition, through DTI’s One Town One Product (OTOP) Program, the packaging and product presentation created a safe and cleaner impression on tinapa products.



Vacuum-sealed smoked fish products were made more competitive with their improved packaging and label through the DTI-SSF and OTOP. The usual tinapa sold alongside the national highway of Nueva Ecija is now frequently exhibited at DTI local Trade Fairs. It can also be brought abroad as “pasalubong” without worrying about its smoky smell and spoilage.

Another highlight of the festival is the ceremonial awarding of the Best SSF in Nueva Ecija for LGU of San Leonardo, with the presence of Mayor Froilan Nagaño of San Leonardo and Dr. Richard V. Simangan, Provincial Director of DTI Nueva Ecija.

DTI Asec. Leonila Baluyut stated that the project is the 3,497th SSF in the country. 
During the February 15, 2023 meeting of the DTI3 CARES MPC, the Board of Directors (BODs) declared the distribution of dividends to its member amounting to 75% of its net income for 2022. The dividend declared is distributed at 60% capital contribution and 40% patronage refund.

The DTI3 CARES MPC is now categorized as a medium-sized cooperative with assets amounting to more than P28M as of December 2022. Total dividend distributed amounted to P1.48M, which is 75% of the total income for 2022.

Membership to the cooperative include all associates working at DTI Region 3 whether they are regular and contractual employees of DTI or those under Job Order or Contract of Service status including third-party service providers like the security personnel of the office. As of February 2023, total cooperative members are at 228.

The Annual Cooperative General Assembly was also held on March 24, 2023 via Zoom platform. The GA was participated by 225 members or 98.68% attendance. The first part of the assembly was the Financial Management Webinar facilitated by Ms. Jasmin P. Barroga of the Cooperative Development Authority (CDA). Financial Management is a mandatory seminar for all cooperatives engaged in credit and savings activity. The Chairman of the Board, Richard V. Simangan, gave the State of the Cooperative Report to all members.

Aside from the provision of the dividends, which was distributed early part of March, the most awaited part of the assembly was the raffle draw, where all attendees received cash



prizes. Additional cash prizes and a microwave oven were some of the major prizes given away to lucky cooperative members.

The last part of the assembly was the awarding of certificate of appreciation to outgoing board of directors and committee members and the oath-taking of newly elected board of directors. The oath of office was led by OIC-RD Brigida T. Pili of DTI Region 3.

The board of directors who were elected and who will be serving for 2 years are from the Regional Office, Bulacan, Nueva Ecija, Pampanga and Zambales Provincial Offices. The new set of Election and Audit Committee members were likewise elected. The other BODs who will continue for another year of service are from Aurora, Bataan and Tarlac Provincial Offices and the Regional Office.


