Inflation Report

This is published quarterly as part of the BSP's transparency mechanism under inflation targeting. This aims to convey to the public the overall thinking and analysis behind the BSP's decision on monetary policy.

Balance of Payments Report

This contains a comprehensive analysis of the developments in the country's balance of payments including the current account (i.e., trade-in-goods and services, income, and current transfers) and the capital and financial account (i.e., direct, portfolio and other investments). Also included are brief discussions on the country's gross international reserves and exchange rate.

Business Expectations Report

This is a report on the results of the quarterly Business Expectations Survey conducted by the BSP to generate indications of overall business sentiment and prospects/outlook.

Consumer Expectations Report

This contains the Consumer Expectations Survey, which captures the economic outlook of consumers as an indication of the country's future economic conditions.

Published twice a year to serve primarily as a forum for presenting the research findings of BSP staff, this review includes analytical and policy-oriented research articles on various economic, financial and statistical issues of interest to the BSP.

Status Report on the Philippine Financial System This is a comprehensive assessment of major developments in the Philippine financial system during a given semester.

<u>Quarterly Report on Economic and Financial</u> <u>Development</u>

This is a quarterly report, which outlines the major developments in the real, monetary and fiscal sectors of the Philippine economy.

Annual Report

A report submitted annually to the President of the Philippines and the Congress, this annual publication highlight the major developments in the Philippine economy, the key activities, policies, and operations of the BSP during the year.

BSP Working Paper Series

The indices can be used as deflators to express a current value in real terms, as bases for wage formulation and forecasting. Specifically, these indices were developed to guide users for a more meaningful economic analysis of current economic behavior and events.

Environmental Degradation Due to Selected Economic Activities

The publication is a compilation of environmental accounts estimating the degradation of the environment brought about by selected economic. It covers five major economic sectors: agriculture, fishery and forestry, manufacturing, mining, electricity generation, and transport services. All estimates are given in both physical and monetary terms, except for the estimates on electricity generation, which are expressed only in physical terms.

Estimation of Fish Biomass in Laguna de Bay Based on Primary Productivity

nutritional needs of Filipinos.

Foreign Direct Investments (FDIs) Report

Contains information on FDIs and investments by Filipinos approved by promotion agencies, FDIs registered with Securities and Exchange Commission (SEC), Bureau of Trade Regulatory and Consumer Protection (BTRCP) and Bangko Sentral ng Pilipinas (BSP) and actual FDIs as presented in the Balance of Payments (BOP) by BSP.

It is a useful input to the development policies, as it monitors the strategy of encouraging foreign investments in the country.

Gross Regional Domestic Expenditures (GRDE)

This provides statistical information on the changes and causes of domestic expenditure. *Annual, 130 pages*

Gross Regional Domestic Product (GRDP)

This presents the aggregate of gross value added (GVA) of all resident producing units in the regions. It is very useful in assessing the region's economic performance, which can provide tools for planning, and decision making, and formulating sound policy.

<u>Philippine Standard Geographic Classification</u> (PSGC)

This provides the standard code for geographic areas of the country that rationalizes and integrates different existing geographic codes being used by various government agencies. With the universal adoption and use of the standardized and integrated geographic code, uniformity and compatibility of statistics produce from related areas at the regional level down to the barangay level by different government agencies is expected to be attained.
